I submit my report as under:

1. The remote e-voting period remained open from 10.00 A.M. IST on Friday, the 23rd August, 2019 up to 5.00 P.M. IST on Sunday, the 25th August, 2019.
2. The Shareholders holding shares as on the "cut off" date, i.e. 19th August, 2019 were entitled to vote on the proposed 6 (Six) resolutions as mentioned in the Notice dated 29th May, 2019 of the Annual General Meeting of the Company.
3. The Company has also distributed the physical ballot forms at the venue of the Annual General Meeting to enable the shareholders to cast the votes physically in case the same has not been casted by them through remote e-voting.
4. The locked ballot box was subsequently opened in my presence and poll/ballot papers were diligently scrutinized. The poll/ballot papers were reconciled with the records maintained by the Registrar and Share Transfer Agents of the Company and the authorizations/ proxies lodged with the Company.

The votes were unblocked on Monday, the 26th August, 2019 around 01:20 P.M. after the completion of the Annual General Meeting in the presence of two witnesses, namely, Ms. Rachana Agarwal, residing at 162/2, Benaras Road, Salkia, Howrah - 711106 and Ms. Anushree Dasgupta residing at 28/N Dwijen Mukherjee Road, Behala, Kolkata – 700060, who are not in employment of the Company.
